RENTAL AGREEMENT & WAIVER OF LIABILITY

Rental Agreement:

I agree that upon renting a kayak, stand-up paddle board or other equipment from Plum Island Kayak **I will not hold Plum Island Kayak, Inc. responsible for any damages** while securing equipment to my vehicle or transporting equipment with my vehicle including damages to my vehicle, other persons other vehicles or other properties, and **herby release, indemnify and hold harmless Plum Island Kayak, Inc.** its employees, agents, owner, assigns or representatives from any and all claims ensuing from securing, transporting or use of such equipment.

I agree to **pay the replacement cost** of any equipment lost or stolen and to **pay the repair cost** for any equipment damaged during my rental term.

I agree to wear a properly fastened Life Jacket at all times while in or on the water.

Waiver of Liability:

In consideration of being allowed to participate in any Plum Island Kayak program, event or activity (including rental activities), I acknowledge and agree that the risk of injury is significant and **I knowingly and freely assume all such risks** both known and unknown and assume full responsibility for my participation. I willingly agree to comply with terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.

While participating in any program or while on the premises of Plum Island Kayak or while a passenger in any Plum Island Kayak vehicle: I for myself and heirs, executors, administrators (and on behalf of any other person whom I am a legal guardian or representative) **herby release, indemnify and hold harmless Plum Island Kayak, Inc.**, its employees, agents, owner, assigns, representatives and lessors of premises used to conduct the event, from any and all claims, demands, losses, and liability arising out of or related to any **Injury, disability, death or property damage.**

I herby grant Plum Island Kayak permission to use, for promotional purposes only, any photograph or video taken of me (by them) during my participation in any Plum Island Kayak activity.
